# **Privacy Policy**

Your privacy is important to us. We respect and are committed to protecting your privacy. This privacy statement explains what personal data this website vagaea.com collects from you and how we use that data. The following discloses the information gathering and dissemination practices of Vagaea Restaurant LLC on the website (the "Services"). It also describes your choices regarding our use of your information and how you can access and update it. By accessing and using the Services of Vagaea Restaurant LLC, you become a user of the Services (the "User", "you", "your") and acknowledge and agree to the following Privacy Policy.

### PERSONAL IDENTIFICATION INFORMATION

We may collect personal identification information from the User in a variety of ways, including, but not limited to, when the User accesses the Services, register on the websites of the Services, fills out a form, and about other activities, services, features, or resources we make available on the Services. #### NON-PERSONAL IDENTIFICATION INFORMATION

## WEB BROWSER COOKIES

The Services may use cookies, invisible pixels, web beacons and other technologies to obtain information about the User. A cookie is a text file sent to the User's browser from a web server and stored on the User's computer's hard drive. It assigns the computer a unique identifier which becomes the User's identifier when the User returns to the Services and related sites. The User may adjust the Internet browser to reject cookies; however, rejecting cookies might affect the User's ability to perform certain transactions, and some parts of the Services may stop functioning correctly. Information collected from invisible pixels is used and reported in the aggregate.

## WHY ARE WE COLLECTING DATA?

We may collect and use the User's personal information for the following purposes and nothing else:

- To personalize user experience: we may use information in the aggregate to understand how our users as a group use the services and resources provided on our Site.

- · To improve our Site: We may use the User's feedback to improve our products and services.
- To send periodic emails: we may use the email address to respond to their inquiries, questions, and/or other requests.

## **HOW WE PROTECT USER INFORMATION**

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of the User's personal information, username, password, transaction information and data stored on our Site.

### SHARING OF PERSONAL INFORMATION

We do not sell, trade, or rent data to third parties. Our data controllers use user data exclusively for legitimate purposes, as mentioned in this document.

## INFORMATION SHARING AND DISCLOSURE

We will never use, sell, share, disclose, or rent any internal or customer-supplied data to any clients, prospects, or third parties other than any venture arising from the constituent hotels within this platform. We will only share user information with third parties in the ways described in this Privacy Policy. Suppose the Company, Provider and/or Services are involved in a merger, acquisition, or sale of all or a portion of their assets. In that case, the User will be notified via email and/or a prominent notice on our website of any change in ownership or uses of the User's information, as well as any choices the User may have regarding the User's information.

We use Google Analytics and Google Tag Manager to collect usage statistics for the Services. Both tools are proprietary to Google, Inc., which may use information collected through said tools for commercial purposes, including, but not limited to, search and ad personalization.
